## ***FISM QUALIFIED CONTEST (FQC)***

Many Presidents and Organizers are asking for their competitions to be FISM Qualified Contest.

This means that there is a growing culture trend towards standardizing the competitions to help magicians always have the same rules and the same kind of evaluation.

Just a few days ago there was an FQC in Bad Aussee (Austria) organized by the Magischer Ring Austria (September 8<sup>th</sup> -11<sup>th</sup> - 2022)


We hope that in the future, there will be another opportunity to help young magicians to compete in FISM WCM.
