FISM Compliant Competition System





- To give all FISM members tools to organize Qualified Competitions in line with the World and Continental Championships
- To raise the level of Magic with Qualified Judges and increase the opportunities for Magicians to test their level according to the FISM rules (International Standard)

## Rules for a competition to be recognized as a FQC

- The Contest Organizer can be, or not, a member of FISM.
- The Jury Panel is composed of at least 50% of FISM Qualified Judges.
- The President of the Jury Panel should preferably be a FISM Qualified Judge.
- The contest will follow the FISM Contest Rules and use the FISM Grading Scale (see slide 8).
- The Organizer will send the names of the judges and their scores to the FISM Board.





- FISM allows the use of the "FISM Qualified Contest" logo.
- Event information and reports will be posted on the FISM website.
- A certificate of "FISM Qualified Contest" will be provided to the organization with the name of the contest and the year.

## **Grading scale**

WCM, Continental, Regional Magic Contests This scale must be applied for qualified FISM contests The jury's members must score with FISM level scale
