No FISM Qualified Contest gives direct access to the FISM CCM and even less to the FISM WCM. A magician can compete in the FISM CCM or WCM ONLY by following the FISM Contest Rules and Procedures art. 1.

FISM ONLINE SCORING SYSTEM

FISM International offers as a service to all FISM Qualified Contest Organizers the opportunity to use the FISM Online Scoring System (OSS). This system was used during the FISM World Championship of Magic 2022 (and FISM European Championship 2021 and many FQCs) and is proven to be both functional and reliable. We continuously strive to enhance its capabilities and features.

Currently, the service requires the presence of a designated FISM official to oversee the system. It's important to note that the system does not need any prior setup and doesn't require any additional devices beyond what the FISM official already owns.

If you are interested in using it as an organizer of FQC, remember to ask for it when you apply for FQC.

FISM'S INITIATIVE TO RAISE AWARENESS ABOUT MUSIC RIGHTS

FISM is launching an initiative to raise awareness about respecting musical rights in magic performances in the FISM competitions, in line with Article 4b of the FISM Contest Rules and Procedures. We emphasize the importance of securing proper rights and licenses for music to ensure ethical and legal practices.

By upholding musical rights, we contribute to both the magic and music industries while fostering professionalism and creativity.


FISM MEMBERSHIP FEE

Please be aware that it is of the utmost importance that your society has paid its contribution for the triennial period 2022-2025. Do not forget that only by paying the membership fee you sponsor candidates to compete in FISM Continental Championships and FISM World Championships, as well as participate in all FISM ballots, either online during the membership period or in person at the WCM General Assembly.

Following the FISM General Assembly decision in Busan 2018 and Quebec 2022, the associations that have still not paid their fees for 3 triennials in a row will be excluded from FISM. If they want to become again members of FISM, they will have to follow Art. 10 of the FISM Statutes.
