Do not forget that only by paying the membership fee you sponsor candidates to compete in FISM Continental Championships and FISM World Championships, as well as participate in all FISM ballots, either online during the membership period or in person at the WCM General Assembly.

Following the FISM General Assembly decision in Busan 2018 and Quebec 2022, the associations that have still not paid their fees for 3 triennials in a row will be excluded from FISM. If they want to become again members of FISM, they will have to follow Art. 10 of the FISM Statutes. 
